FLOOR AMENDMENT EXPLANATION

- Amends the misconduct involving weapons statutes to include selling or transferring a firearm at a firearms show without requiring the purchaser of the firearm to show proof of citizenship. The proof of citizenship required is the same proof that is required for a person to vote.
- A violation of this section is Class 4 Felony.
- Provides that this section does not apply to a firearm exhibitor that requires a background check.

1 Page 5, between lines 29 and 30, insert:

2 "14. SELLING OR TRANSFERRING A FIREARM AT A FIREARM SHOW WITHOUT
3 REQUIRING THE PURCHASER OR TRANSFEREE TO PROVIDE PROOF OF CITIZENSHIP. A
4 VIOLATION OF THIS PARAGRAPH IS A CLASS 4 FELONY."

5 Page 7, between lines 28 and 29, insert:

6 "H. SUBSECTION A, PARAGRAPH 14 OF THIS SECTION DOES NOT APPLY TO A
7 FIREARM EXHIBITOR WHO REQUIRES A BACKGROUND CHECK."

8 Reletter to conform

9 Page 8, between lines 11 and 12, insert:

10 "2. "FIREARM EXHIBITOR" MEANS ANY PERSON WHO EXHIBITS, SELLS, OFFERS
11 FOR SALE, TRANSFERS OR EXCHANGES FIREARMS AT A FIREARM SHOW.

12 3. "FIREARM SHOW" MEANS AN EVENT THAT IS SPONSORED, WHETHER FOR PROFIT
13 OR NOT, BY AN INDIVIDUAL, NATIONAL, STATE OR LOCAL ORGANIZATION, ASSOCIATION
14 OR OTHER ENTITY DEVOTED TO THE COLLECTION, COMPETITIVE USE, SPORTING USE OR
15 ANY OTHER LEGAL USE OF FIREARMS AND EITHER OF THE FOLLOWING APPLIES:

16 (a) TEN OR MORE FIREARM EXHIBITORS ARE PARTICIPATING.

17 (b) A TOTAL OF TWENTY-FIVE OR MORE PISTOLS OR REVOLVERS ARE OFFERED
18 FOR SALE OR TRANSFER.

19 4. "PROOF OF CITIZENSHIP" MEANS ANY OF THE FOLLOWING:

20 (a) AN ARIZONA DRIVER LICENSE OR NONOPERATING IDENTIFICATION LICENSE
21 ISSUED AFTER OCTOBER 1, 1996.

22 (b) A LEGIBLE PHOTOCOPY OF A BIRTH CERTIFICATE THAT VERIFIES
23 CITIZENSHIP AND SUPPORTING LEGAL DOCUMENTATION, INCLUDING A MARRIAGE
24 CERTIFICATE, IF THE NAME ON THE BIRTH CERTIFICATE IS NOT THE SAME AS THE
25 PERSON'S LEGAL NAME.

26 (c) A LEGIBLE PHOTOCOPY OF PERTINENT PAGES OF A UNITED STATES PASSPORT
27 IDENTIFYING THE PERSON.

1 (d) UNITED STATES NATURALIZATION DOCUMENTS.

2 (e) THE PERSON'S BUREAU OF INDIAN AFFAIRS CARD NUMBER OR TRIBAL TREATY
3 CARD NUMBER.

4 (f) A LEGIBLE PHOTOCOPY OF A DRIVER LICENSE OR NONOPERATING
5 IDENTIFICATION LICENSE FROM ANOTHER STATE WITHIN THE UNITED STATES IF THE
6 LICENSE INDICATES THAT THE PERSON HAS PROVIDED SATISFACTORY PROOF OF
7 CITIZENSHIP.

8 (g) A LEGIBLE PHOTOCOPY OF A TRIBAL CERTIFICATE OF INDIAN BLOOD OR
9 TRIBAL OR BUREAU OF INDIAN AFFAIRS AFFIDAVIT OF BIRTH."
